Identity checking guidelines for Disclosure Checks:

3 primary documents to be checked – one from Group 1 and two from Group 1, 2a or 2b. Applicant's current address must be verified by at least one document. One document to be verified from Group 2a and two from Group 2a or 2b. Applicant's current address must be verified by at least one document. External 1D validation of the applicant required through Route Two.

A certified copy a UK Birth Certificate to be checked (UK and Channel Islands, issued after the time of birth by the General Register Office/relevant authority). Four additional documents from Group 2, including one from Group 2a and three from Group 2a or 2b to be checked as well. Applicant's current address must be verified by at least one document.
